END USER LICENSE AGREEMENT

IMPORTANT NOTICE: PLEASE READ THIS END USER LICENSE AGREEMENT ("AGREEMENT") CAREFULLY BEFORE USING THE EMINOX SERVICE TOOL SOFTWARE. BY DOWNLOADING, INSTALLING, OR USING THIS SOFTWARE, YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT INSTALL OR USE THE SOFTWARE.

1. LICENSE GRANT

In return for a license fee, Eminox Ltd ("Licensor") hereby grants you ("Licensee") a non-exclusive, non-transferable, revocable license to use the "Eminox Service Tool" software ("Software") for the purpose of flashing, calibrating, and monitoring after treatment electronic control units ("Purpose"), in accordance with the terms of this Agreement. Upon payment of the license fee the Licensee will be entitled to a license key to be issued by the Licensor which shall be valid for a finite period. The Licensor does not sell the Software or Documents to you and remains the owner of the Software and Documents at all times.

2. RESTRICTIONS ON USE

- **Business Use Only:** The Software is licensed for Licensee's internal business use only. Personal or consumer use is strictly prohibited.
- **No Reverse Engineering:** Licensee may not reverse engineer, decompile, modify or disassemble the Software.
- **No Redistribution:** Licensee may not make copies, transfer, rent, lease, lend, sublicense, distribute, or sell copies of the Software to any third party.

3. OPEN SOURCE COMPONENTS

The Software includes certain open-source components that are licensed under separate terms. Licensee agrees to comply with the terms of these open-source licenses, which are included in the Software's documentation.

4. SUPPORT AND UPDATES

Licensor will provide support and updates for the Software as deemed necessary. Licensor is not obligated to provide updates, enhancements, or modifications unless specified in a separate agreement.

5. WARRANTY DISCLAIMER

THE SOFTWARE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND. LICENSOR DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.

6. LIMITATION OF LIABILITY

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL LICENSOR BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, OR ANY DAMAGES WHATSOEVER, INCLUDING BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS, REVENUE, DATA, OR USE, INCURRED BY YOU OR ANY THIRD PARTY, WHETHER IN AN ACTION IN CONTRACT OR TORT, ARISING OUT OF OR IN CONNECTION WITH YOUR ACCESS TO OR USE OF THE SOFTWARE, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, LICENSOR'S TOTAL LIABILITY FOR DAMAGES SHALL NOT EXCEED THE AMOUNT PAID FOR THE SOFTWARE.

7. INDEMNIFICATION

Licensee agrees to indemnify, defend, and hold harmless Licensor from and against any and all claims, losses, liabilities, damages, expenses, and costs (including reasonable attorneys' fees) arising out of or related to Licensee's use or misuse of the Software, or any violation of this Agreement.

8. INTELLECTUAL PROPERTY RIGHTS

The Licensee acknowledge that all intellectual property rights in the Software and the Documents belongs to the Licensor that rights in the Software is licensed (not sold) to it, and that the Licensee shall have no rights in, or to, the Software or the Documents other than the right to use them in accordance with the terms of this Agreement. The Licensee also acknowledges that it has no right to access to the Software in source code form.

9. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of England and Wales. Any disputes arising out of or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of England and Wales.

10 TERMINATION

This Agreement is effective until the license key expiry date. Licensee's rights under this Agreement will terminate automatically without notice if Licensee fails to comply with any of the terms and conditions of this Agreement. Upon termination, Licensee must cease all use of the Software and immediately and permanently delete or remove the Software from all computer equipment in Licensee's possession, and immediately destroy or return to Licensor (at Licensor's option) all copies of the Software and Documents then in Licensee's possession, custody or control and, in the case of destruction, certify to Licensor that it has done so.

11. ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties with respect to the use of the Software and supersedes all prior or contemporaneous understandings regarding such subject matter. No amendment to or modification of this Agreement will be binding unless in writing and signed by Licensor.

12. SEVERABILITY

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.

13. DATA PROTECTION

Under data protection legislation, the Licensor is required to provide the Licensee with certain information about who it is, how it processes personal data of individuals who use the Software and the Documents, for what purposes and those individuals' rights in relation to their personal data and how to exercise them. This information is provided in the [Eminox Privacy Policy](#) and it is important that the Licensee reads that information.

14. NO WAIVER

No failure or delay by any party to exercise any right, power or remedy will operate as a waiver of it nor will any partial exercise preclude any further exercise of the same, or of some other right, power or remedy.
